2. Approval of Jan. 11, 2012 Finance Committee Meeting Minutes.

Motion by: Todd Rubinstein, Second: Diane Rosen, APPROVED unanimously.

3. Discussion of the 2011 2012 ENC Budget and expenses to date and Update on

Quarterly Audit Reports.

Items reviewed.

- 4. Funding requests from ENC Committees:
- A. Encumbrance of \$10,500.00 of 2011 2012 Fiscal Year (F.Y.) funds, to supplement the \$1,000.00 in the current F.Y. budget, for anticipated 2012 ENC election expenses (Executive Committee).

Motion by: Todd Rubinstein, Second: Diane Rosen, to encumber \$10,500 of 2011-12 fiscal year funds for elections to be held in 2012-13 fiscal year. Currently budgeted \$1,000.00 for election expenses to remain in 2011-12 fiscal year. APPROVED unanimously.

B. Maximum \$5,000.00 to fund local school projects (Education Committee).

Motion by: Glenn Bailey, Second: Todd Rubinstein, to transfer \$3,500.00 from Community Improvement Projects to Neighborhood Purpose Grants to provide the Education Committee with funds for local school projects. APPROVED unanimously.

- C. Maximum \$500.00 toward purchase of HAM Radio (Public Safety Committee). Expenditure approved at the January 25, 2012 ENC General Board Meeting. No discussion.
- D. Maximum \$500.00 for Cycle Against Denial program (Public Safety Committee).

Motion by: Diane Rosen, Second: Glenn Bailey, to approve expenditure. The vote results were: Approve: 3, Oppose: 1, Abstain: 1

E. Maximum \$500.00 to purchase emergency preparedness kits for West Valley LAPD patrol cars (Public Safety Committee).

approved at July 27, 2011 ENC General Board Meeting. APPROVED unanimously.

F. \$1,000.00 for May 19, 2012 Senior Symposium at ONEgeneration Senior Enrichment Center (Outreach Committee).
