A. Encino has more than 45,000 residents – the ENC should attempt to reach out to each household to inform them about the ENC. Although more people are attending ENC meetings, we need to be able to reach many more in order to create robust discussions regarding pressing issues.

- B. Waste Management Since Waste Management received the new contract the fees they charge have increased, in some cases 300% or more. HOA's and businesses may not be aware that by contract, they can request a "waste assessment." This can reduce the fee. At 5339 Newcastle, they had been paying \$450/mo with So Cal Waste. With WM the new fees exceeded \$1700/mo after requesting the waste assessment their fees were reduced to \$550/mo. How can we effectively reach the HOA's, building owners and commercial property owners facing these new fees to advise them that they can be reduced?

Public comment is limited to 2 minutes per speaker per item, unless adjusted by the presiding officer of the Board or Committee.
