A. Clock for ENC Meetings – To streamline ENC meetings, it would be beneficial to have a clock that counts down the time for each speaker. A visual aid will help speakers and will help the flow of the ENC meetings. - B. **ENC Pins** ENC members should have a distinctive identifier for use at ENC meetings and when attending events. Lapel pins are an inexpensive way to identify board members. Pinmart has several options. **Motion:** The Outreach Committee is requesting up to \$285 for 100 enamel pins from Pinmart.
- C. Community Center Digital Sign/Marquee With the Community Center renovations well on their way, a digital sign/marquee would benefit the Community Center, The Chamber and the ENC. A digital sign would be used to promote functions, meetings and general announcements. **Motion:** The Outreach Committee is requesting up to \$6,000 for a digital sign to be placed outside the Community Center.
- D. ENC T-Shirts/Polo Shirts When we attend events it might be a good idea to have shirts with our logo on them. A green polo with Encino Neighborhood Council? They can also be used at ENC meetings.
 MOTION: The Outreach Committee is requesting \$650 to purchase 48 Polo Shirts signs from Marco Promotions for Board Members to use at ENC events and ENC Meetings.
- E. Light Pole Banners The AmGraph Group is able to provide NC's with light pole banners. We have received 2 quotes, one for 40 single banners and one for 20 double banners. AmGraph has confirmed: NC's are not charged a permit fee and that once approved granted a 1 year placement. Locations could be Ventura Blvd., or Balboa Blvd. near the Community Center. The estimates did not include tax. The total for 20 double banners is \$4,906.41 and \$5,466.41 for 40 single banners. The ENC will receive the banners once they are taken down. This represents advertising for 1 year. Motion: The Outreach Committee requests up to \$5,500 for light pole banners.
- **F. District 45 Candidates** There will be a special election on April 3rd to narrow the field down for the State Assembly District 45 election. Once the field is narrowed down, would we like to invite them to the ENC for a short forum so that they can introduce themselves, present their platform and field questions from Stakeholders? **Motion:** The Outreach Committee would like to invite the remaining candidates from the April 3rd, District 45 election to the next ENC meeting for a short forum.
- **G. PLU Outreach** The PLU Committee is requesting \$1000 for mailers for upcoming notices regarding developments. The \$1000 will cover envelopes, stamps, paper and printing costs. **Motion:** The Outreach Committee is requesting \$1000 to cover the costs of envelopes, stamps, paper and printing costs for the PLU Committee's Outreach mailer campaigns.
