A. **Encino Family Festival** – Overview of the day, who will be at the booth and what times. Our new give-away needs to be discussed. Collection of emails and recruit new Stakeholders to committees with a focus on the Homelessness Committee and Government Committee.



- B. Welcome to Encino Sign It's been over 1 year since our tile on the Welcome to Encino sign was placed. The yearly maintenance fee of \$500 is due. Would we like to continue to have our tile, reading Encino Neighborhood Council, on the Welcome to Encino sign? MOTION; OUT-18-9-0005: The Outreach Committee supports the continued placement of the ENC tile on the Welcome to Encino sign located at Balboa and Victory and requests \$500 for the yearly fee. Passed:
- C. ENC Flash Lights We have several ENC Flash Lights that had been ordered a long while ago. The information on the labels is incorrect. There are about 145 flashlights, all need new inserts (see sample). About half do not work because the batteries have expired. We can handle the printing but we need to purchase new AAA batteries. Rather than throwing out the flashlights that were purchased, we can revitalize them with new inserts and new batteries and use them as handouts at the Encino Family Festival. MOTION; OUT-18-9-0006: The Outreach Committee is requesting up to \$200 to cover the cost of 145 AAA batteries.
- D. Walk of Freedom 2018 There will be a Walk of Freedom on October 6th at Woodley Park. The walk is put on by Journey Out, a non-profit in Van Nuys. They are a non-governmental, non-profit that has been carrying out the mission of "helping victims of commercial sexual exploitation and sex trafficking leave a life of abuse and violence, overcome their fears, and empower them to reach their full potential and achieve their goals". The notice about the event came a little too late for having a booth or to provide funding support, however, we can blast using our social media.
- **E. 405 Underpass Revitalization** The Sherman Oaks NC would like to partner up with the ENC to revitalize the underpass on Ventura Blvd. under the 405. The ultimate goal would be to have a mural painted on the walls but before that is done the underpass needs some improvements, such as; new lighting, fix of possible leaks onto walls when it rains and the walls need to be cleaned and possibly re-done to include a smooth surface so a mural can be painted. **MOTION; OUT-18-9-0007**: The Outreach Committee supports teaming up with the Sherman Oaks NC to start moving forward with revitalizing the underpass under the 405 Freeway on Ventura Blvd. Passed:
- **F.** Clean Up Encino Project The Chamber hosted a Clean Up Encino Day and is setting up to host another in March or so of 2019. Encino residents have commented that Rwanda has a monthly cleanup day, usually the 1st Saturday of each month. Due to religious observances Saturdays would prevent the 1st Saturday, perhaps the 1st Sunday of each month could be a community cleanup day. This would require a collaborative effort between the Chamber, businesses and the CD5 office. Would the ENC Outreach Committee like to begin coordinating a monthly or quarterly cleanup day in Encino where residents and businesses could participate? **MOTION; OUT-189-0008**: The ENC Outreach Committee is requesting support from the Encino Neighborhood Council to begin coordinating a (monthly/quarterly) cleanup day in Encino. Passed:
