## Council File 20-0065, Interim Control Ordinance / Private Detention Centers:

Introduced on January 17, 2020 and referred to Planning and Land Use Management Committee. Motion referred to Council and tentatively scheduled for January 22, 2020. Motion is instructing the Planning Department in consultation with the City Attorney to prepare and process an Interim Control Ordinance (ICO) to prohibit the issuance of any demolition, building, grading, and any other applicable permits to prevent the construction or operation of private detention centers, inclusive of facilities wherein all person, regardless of their citizenship status, are detained, confined, or under restraint or security pending the resolution of any judicial or administrative proceedings, inclusive

of detention facilities for separated or unaccompanied minors, and that are operated by private, non-governmental entities.
