  - A. ENC Outreach How will the ENC conduct outreach given that most of the events that were planned have either been cancelled or have moved to virtual events. The following event is still scheduled to take place: Valley Disaster Preparedness Fair in October. Discussion and possible action.
  - **B.** Movie at the Park As restrictions ease should the ENC plan on a Movie at the Park night in the fall? Good points are that the movie can start earlier since the sun sets earlier and we can plan on a weekend since kids will be in school. Unknowns and concerns at this time are: fall weather (possibility of rain), what if any social distancing will be in place and what size limitations will there be on gatherings. An October night may work, often weather is still warm even with the sun setting earlier. Another option, if a movie at the park is not possible would be to have a drive-in move with the LBNC at Lake Balboa or Balboa Park. **Discussion and possible action**.
  - C. Zoom Meetings Discussion on using the ENC's Zoom account for City meetings or other meetings relevant to the ENC, such as a Neighborhood Watch meeting, forum with the Councilmember or other officials from the County or State. Discussion and possible action.
  - **D.** Mask Signs for Encino Parks and Hiking Trails Currently there is no signage advising the public that masks should be worn at our parks and hiking trails. An ENC Board Member brought up the possibility of the ENC purchasing signs for the hiking trails near the Nike Missile site, Balboa Park, Sepulveda Basin and the Off Leash Dog Park. Issue is that the basin and Balboa Park are not in CD5 and the ENC should consult and request assistance in funding from the LBNC and Tarzana NC. The hiking trails have 2 entrances, one in Encino at Mulholland and two on Reseda Blvd. in Tarzana. Encino residents use all the entrances to the trails? A 7" x 10" sign from My Safety Sign are reasonable. The cost depends on if we want plastic or aluminum signs. For 50 plastic signs they come to \$275.50 plus shipping or \$413.50 plus shipping for aluminum ones. **Discussion and possible action.**

Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minutes per speaker per item, unless adjusted by the presiding officer of the Board or Committee.
