- **B.** Trees for Coivd As of the date this agenda was created, according to the LA County Covid site, there have been 27 deaths in Encino related to Covid. Should the ENC work with City Council to plant trees in remembrance to those that have passed unnecessarily with plaques? The City should waive any permits to plant and should be able to donate the trees...the ENC would be responsible for the plaques. Discussion and possible action.
- After much discussion and possible ideas, the consensus from the committee is to have a bench with a plaque (honoring those that passed from Covid) as well as planting a tree next to the bench. Without the costs of the bench, the item could not be voted on.
