 - A) Beyond Coal Ms. Rivlin restated her motion, with Mr. Gamson's 2nd, "To endorse the Beyond Coal campaign to eliminate coal from the electricity supply of Los Angeles by 2020 by investing in a combination of energy efficiency, solar, wind, and geothermal. Also to send a letter of support for the Beyond Coal campaign to Council members Koretz, Englander, and Cardenas. Passed 10 to 9, with 1 abstention.
 - B) Legado Oak View project Developers presented the project and community was given equal time to respond.

- 10. Committee Reports: (8:40 PM 9:00 PM)
 - Executive Report
 Kaufman moved 2nd by Ms. Kelson a donation for \$500.00 toward food expenses for the Daddy Daughter Prom (2012). Passed unanimously
 - By-Laws
- A. Discussion regarding motion on Sanctioning and Removal of Board Members in Violation. This is a past-discussed item.

DONE provided template formatting with LA CITY ATTORNEY guidance for bylaws and standing rules and requested NCs include it. Sent to Adhoc committee and then back to bylaws.

Mr. Bailey presented the following motion from bylaws committee: 3B. MOTION (Rosen/Steinberg) to recommend that the Neighborhood Council Bylaws Template Language relating to Removal of Governing Board Members (Section 9 of Article V), Section 2 Petition by Board, if and when considered as a Bylaws amendment, that option 1 number of signatures be 14 Board members and that option 2 removal of the identified Board member requires 2/3 majority.

Call for the question failed. In subsequent discussion, Ms. Patterson submitted the following wording:

A Board Member may be removed from the Board for good cause, including, but not limited to, disruptive conduct; Interfering with Council business; violations of the Bylaws, Operating Procedures or Code of Conduct following a Board Member's submission to the Board of a petition which includes: I) the identity of the Board Member to be removed, ii) states the reason for removal by identifying the violation of the internal rules or procedures and specifies the conduct of the person, and iii) contains the signatures of at least [3] Board members.

a. The petition shall be delivered simultaneously to all Board Members and the matter placed on the agenda and scheduled for a vote at the next regular Board Meeting.

- b. Removal of the identified Board member requires a majority of the attending Board Members.
- c. The Board Member who is the subject of the removal action shall have the right to deliver to Board Members a written statement about the matter and/or to speak at the Board Meeting prior to the vote, but shall not be counted as part of the quorum, nor allowed to vote on the matter.
- d. The Board member being removed must first have been censured by the Board once for the same action before a Petition by the Board for removal shall be considered by the Council. If the vote for removal is affirmative, the position shall be deemed vacant and filled via the Council's vacancy clause.

Amendment passed by 9 pro, 8 opposed, 2 abstained and is on track for 2nd reading at the next board meeting.

B. Original Motion by: Greg Martayan2nd by: Gerald Silver Article5, Section 8: Censure - "The Council can take action to publically reprimand a Board member for actions conducted in the course of Council business by censuring the Board member at a Council Board meeting.

Censures shall be placed on the agenda for discussion and action". This is the second reading of the motion. Passed 9 pro, 6 opposed, 3 abstain.

- C. Bylaws Committee Meeting November 30, 2011 CONSENT ITEMS
 - 1. Proposed Cancellation of 2012 Neighborhood Council Elections: Proposed Ordinance CF11-1912 City Attorney report and Ordinance relative to amending Sections20.36 and 22.816 of the Los Angeles Administrative Code (LAAC) relating to neighborhood council elections
 - 1A. MOTION (Brewer/Steinberg) to recommend that the Encino Neighborhood Council (1) oppose the proposed ordinance as drafted which would cancel Neighborhood Council elections in 2012 and (2) support Neighborhood Councils having the ability to conduct an election, selection, or to opt out for 2012.

The majority of the Board voted to not postpone the elections until 2014. Ms. Kelson allowed one more week for members to submit their preferences for conducting the elections. Surveys are to be sent to Mr. Bailey for tabulating.
