- b. Outreach Committee Motion to provide a food budget for Outreach Committee Meetings in budget (fiscal) year 2015/2016 of up to \$79 per meeting not to exceed 9 meetings for a total of \$891.00.
- c. <u>Friends of Encino / Encino Community Center</u> Musical Theater Program Aladdin the Musical. Production will start in January 2016 thru May 2015. We would like for ENC to sponsor the royalties of the show at \$735.00; deadline for payment is 11/10/15. This sponsorship will allow for use those funds for purchase of costumes, props, staging and staff.
- - (1) Election Procedures Stipulation Worksheet The following information provides the primary elements for this Neighborhood Council (NC) election and is taken from the NC's Bylaws and 2016 Election Procedures. This worksheet supplements the policies and procedures in the Neighborhood Council 2016 Election Manual. Board action to confirm the information and to provide the additional information (*) needed to administer the election. The Board has until Friday, October 30, 2015 at 5 pm to provide specific elections information per the Stipulation Sheet per 10/21/15 email from Elections Admin and Outreach Coordinator.
 - (2) Election Time: Please provide a four (4) hour window between the hours of 9:00 a.m. to 8:00 p.m. for the Department to hold the elections. (If only three (3) or fewer seats are contested and have more than one candidate, then EmpowerLA may hold a shortened election time of two (2) hours for the Neighborhood Council. The first two (2) hours of the selected four (4) hours time frame will be used to hold the Elections.)

- (3) Election Location Polling Place must be within the NC's boundaries, comply with the Americans with Disabilities Act, have adequate parking, and be available on the Election Day two hours before and after the election time window. Location fee must be paid by the NC, and the Department will reimburse a maximum of \$200 of the amount. Default will be the Department's selection.
- (4) Translation In addition to English, Neighborhood Councils may select additional language(s). After the first language, additional languages will cost \$50 per language. Approval is subject to EmpowerLA approval and requires an Outreach Plan for the stakeholders that speak that language. Specify which languages NC would like to have on Candidate Forms, Voter Registration, spoken at the Polling Location and on NC Election / Outreach Contact Information.
- e. <u>By-Laws Committee Meeting</u> Motion(s) passed at By-Laws Committee Meeting on August 17, 2015 to make the following changes in the Standing Rules:
 - (1) To change second sentence in Paragraph 1B which limits comment period by adding "unless time is extended by simple majority vote of the board" (Motion by Jason Ackerman, seconded by Ken Silk adopted 5-0).
 - (2) To correct spelling in the last sentence of Paragraph 1B by changing "rime limit" to "time limit."
 - (3) To add at the end of Paragraph 1C regarding alternate views by adding "Before a vote is taken on a motion to close debate the President will give an opportunity for at least one member to state opposition the member may have to the motion." (Motion by Ken Silk, seconded by Sherman Gamson adopted 5-0),
 - (4) To change second sentence of Paragraph 1F setting forth requirement for committee vote to constitute a consent item from being adopted by the committee "unanimously" to "without any no vote". This will make it clear that an abstention will not prevent a committed resolution from being a consent item. (Motion by Ken Silk, seconded by Sherman Gamson adopted 5-0)
 - (5) To change third sentence of Paragraph 1F referring to adoption of consent items at board meeting from being by "representatives present" to "board members present." (Motion by Ken Silk, seconded by Sherman Gamson adopted 5-0).
 - (6) To change third sentence of Paragraph 1F referring to an objection to a consent item by a "Representative" by adding objection by "alternate or stakeholder who submitted a public comment card." (Motion by Ken Silk, seconded by Sherman Gamson adopted 5-0)

PLANNING AND LAND USE COMMITTEE DOES NOT OPPOSE THE 10 YEAR RENEWAL FOR TYPE 20 FOR SUPER SAL MARKET 17630 VENTURA BLVD, ZA 2003-2041-CUB, AS PRESENTED FOR RENEWING CONDITIONAL USE PERMIT TO ALLOW THE CONTINUED SALE AND DISPENSING FOR CONSIDERATION OF BEER AND WINE FOR OFF-SITE CONSUMPTION, AS AN ACCESSORY USE, IN CONJUNCTION WITH AN EXISTING 7,857 SQ FT KOSHER MARKET. Motion by Hudgins / 2nd by Cohen. 5-0-0 Unanimous approval.

- (2) Tapia Brothers Farms / Hjetle Fields-(RE-CF:14-0133): While The Encino Neighborhood Council understands the need for additional athletic recreational venues within the San Fernando Valley, however it also understands that there is a need to protect what little agricultural land is left in the San Fernando Valley. The Encino Neighborhood Council therefore opposes the expansion of the Hjelte Fields facility or any other athletic facility into and on to the following parcels within the Sepulveda Basin: 7, 10, 12, 13, and 14. **Motion out of Committee**: The ENC opposes the expansion of the Hjelte Fields facility or any other athletic facility into and on to the following parcels within the Sepulveda Basin: 7, 10, 12, 13, and 14. Due to the need to keep an agricultural green zone in the valley. Motion by Ackerman / 2nd by Silver. 6-0-0 Unanimous approval.

<u>PUBLIC INPUT AT ENC MEETINGS</u> - An opportunity for the public to address the Council or Speaker on agenda items will be provided before or during consideration of the item. Members of the public who wish to be recognized on any item are requested to complete a question card for each item they wish to address, and present the completed card(s) to the Sergeant-At-Arms. Speaker cards are available at the back of the meeting room. The Council will also provide an opportunity for the public to speak on any [Non-Agenda Items*] during "Public Comment". The Council may not take any action or discuss matters addressed in "Public Comments". However, the Council President may refer such matters to the appropriate Council Committees for further consideration.

* Public comments are limited to TWO (2) minutes per speaker.

ENC BOARD DISCUSSION AND TIME LIMITS – an ENC Board member's request to speak will be recognized by the President in the order requested. For any item, the Chairperson of the Committee, or the maker of the original motion shall have up to THREE (3) minutes to discuss the item. Board members may speak for up to TWO (2) minutes each on the matter unless extended by the President or Council. After all members desiring to speak on a question have had an opportunity to be heard once, the time for each Member desiring to speak again shall be limited to a maximum of ONE (1) minute unless extended by the President or Council. A motion calling the "Previous Question" may be introduced by any member during a Council debate. If adopted, this motion will terminate debate on a matter and the matter will then be submitted for a vote.

<u>VOTING AND DISPOSITION OF ITEMS</u> - Most motions require a majority vote of the Board member's present and voting will be by hand vote unless otherwise decided by the Council. Unless requested for further consideration by an ENC Board member, any item that has been forwarded to the Council by a unanimous committee vote shall be approved as a "Consent Item" without further discussion.
