8. New Business

A. 4741 Libbit Presentation (15 minutes). The developer's team will provide a short presentation on the changes that they will incorporate into the design of the development at 4741 Libbit. Both the residents that live near the development and the ENC have objected to the current design due to lack of parking, size of each small unit, a roof top pool that faces residential homes and other concerns that do not accommodate the local residents. The presentation will consist of the changes they will incorporate based on initial feedback.

9. Consent Items (30 minutes)

Outreach Committee (Funding - Consent):

- **A. Senior Symposium 2019 MOTION; OUT-19-01-0011**: The ENC Outreach Committee recommends attending the 2019 One Generation Senior Symposium on May 18, 2019 and requests approval of the \$750 expenditure for the booth. The ENC will be recognized as a "lunch" contributor. **Passed 5-0-0**.
- **B.** Acrylic Tri-Fold and Brochure Holders MOTION; OUT-19-01-0012: The ENC Outreach Committee supports purchasing 2-3 acrylic or similar brochure holders for events to hold our tri-fold brochures, info cards and other standard size handouts (8.5" x 11") from Office Depot, Amazon or similar retailer. The cost will not exceed \$100. **Passed 5-0-0**.

Outreach Committee (Non-Funding Consent)

- C. ENC Town Hall on Crime The CD5 office was supposed to setup a forum on crime, it was postponed without a new date. Many Encino residents would like a forum on crime, rather than waiting, the ENC should take the lead, set a date, invite presenters and host the forum with the assistance of the ENC's Public Safety Committee. MOTION; OUT-19-01-0013: The ENC Outreach Committee supports taking the lead with the support of the ENC's Public Safety Committee and hosting the town hall forum on crime. Passed: 5-0-0
- D. Restaurant Tour Event A good way to introduce our residents to our local restaurant would be for the ENC to setup a restaurant tour day event. Local restaurants would be invited to participate over three days (Monday thru Wednesday) with a menu at a set price. Each restaurant would setup a tour event menu with a fixed price. The Chamber would be instrumental in assisting to have restaurants participate. MOTION; OUT-19-01-0014: The ENC's Outreach Committee will begin to explore dates and create an action plan on contacting restaurants to participate. There should be no cost to the ENC. Passed: 5-0-0.

Executive Committee (Non-Funding Consent Items):

- **E. NORMS MOTION; EXE-19-01-0035** The ENC Executive Committee supports having a NORMS in Encino based on the information provided by the ENC's PLU Committee. **Passed: 4-0-0**.
- **F. Ad-HOC Airport Committee** Encino has seen an increase in low flights both from the Van Nuys Airport and Burbank Airport. **MOTION; EXE-19-01-0036:** The ENC Executive Committee would like to create a special Ad-HOC Airport Committee to deal with the increased traffic at VNY and new flight paths from BUR. **Passed 4-0-0**.



G. DONE Rep Assessment – In order for us to work closely with DONE, the ENC should conduct a yearly assessment of our representative. The Executive Committee will complete the assessment and shared with the board for additional assessments/comments & approval. See: http://www.encinonc.org/docs/34483253-5231.pdf

MOTION; EXE-19-01-0037: The ENC's Executive Committee approves conducting an assessment of our DONE Representative based on an information sheet of the DONE Reps responsibilities. The assessment will be a report card style assessment with each point receiving; Exceeds Expectation, Meets Expectation, Does Not Meet Expectation. **Passed 4-0-0**

- H. Child Care/Babysitting Services for NCs Over the years younger families are moving into Encino, many would like to either come to ENC meetings or be part of the ENC but require childcare or babysitting services in order to attend. Ordinance 176704 and the Plan for a citywide system of neighborhood councils both state that translation services and childcare services would be provided for elections and the formation of neighborhood councils. Translation services continue to be offered however childcare is not currently provided. Our residents, the ENC and the City would benefit if childcare or babysitting services are provided during General Board meetings. The Arroyo Seco Neighborhood Council has introduced a motion for such services. The ENC benefits from having meetings at the Community Center. MOTION; EXE-19-01-0038: The ENC's Executive Committee supports beginning discussions with the Community Center and City to offer childcare services provided during General Board meetings. - I. CF 15-0499-S1 (http://clkrep.lacity.org/onlinedocs/2015/15-0499-s1 mot 10-17-2018.pdf) The City has introduced a council file for the protection of our urban canopy. The ENC should consider submitting a CIS for CF 15-0499-S1 in support of if it includes the proposals set forth in ENC-PLU-18-08-0002 (the motion the ENC passed August 22nd, 2018 with the ENC's recommendations and fix to the municipal code to protect our urban canopy). MOTION; EXE-19-01-0039: The ENC to file a CIS to Support with Conditions CF 15-0499-S1 if it includes the recommendations and fixes to the municipal code proposed in the approved language of ENC-PLU-08-0002 . Passed: 4-0-0.

J. Sound Cloud Account Upgrade – At the May 23rd, 2018 ENC General Board Meeting, the ENC approved upgrading the ENC's Sound Cloud Account to Pro Unlimited. Action was not taken prior to our new fiscal year. If paid annually the cost is \$145 per year or we can pay monthly at a monthly cost of \$16 per month. **MOTION**; **EXE-19-01-0040**: The ENC's Executive Committee supports upgrading the ENC's Sound Cloud Account and paying annually to reduce the total cost. **Passed 4-0-0**
