8. Funding Requests - NPGs & Funding (Consent – 10 min):

8-A. NPG – Valley Arts Cultural Center: The ENC has received an NPG request for a PopUp Art Event at Genesta Park. The tentative date is September 21st 2019. The amount requested from the ENC is \$4000. Additional contributions have been made by Councilmember Koretz for the event. MOTION; EXE-19-06-0059: The ENC's Executive Committee recommends allocating \$4,000, from the 2019/2020 approved budget and requests approval from the Encino Neighborhood Council. **Passed 5-0-0**

8-B. Congress of Neighborhoods: Discussion and possible action. The ENC has available funds from the 2018/2019 budget. **MOTION; EXE-19-06-0060**: The ENC's Executive Committee recommends that the Encino Neighborhood Council approve allocating \$750, from the 2019/2020 approved budget to the Congress of Neighborhoods. **Passed: 5-0-0**

8-C. Budget Advocates: Discussion and possible action. The budget advocates are a non-paid group that service neighborhood councils. **MOTION; EXE-19-06-0061**: The ENC's Executive Committee recommends that the Encino Neighborhood Council approve allocating \$500 from the 2019/2020 approved budget to the Budget Advocates. **Passed: 5-0-0**

(Voted with 8B - 17,0,0,1)

8-D. Encino Family Festival – The ENC participates in Encino's largest fair each year, the Encino Family Festival. This year the festival will be on October 10th. We have been granted a discount, the breakdown of costs are: \$175 for the booth, \$100 for Electricity, & \$184 for the Health Permit. The Chamber is waiving the corner booth fee for the 2019 festival. **MOTION; EXE-19-06-0064**: The ENC's Executive Committee recommends that the ENC attend the Encino Family Festival and requests that the Encino Neighborhood Council approve up to \$650 for the Festival. **Passed: 5-0-0**

9. New Business – Consent Items (Non-Funding – 10 min):

Executive Committee (Consent Items):

9-A. Cleanup of Burbank Blvd. & Haskell Creek: 5 min presentation. Two areas have been identified as potential environmental risk sites. The areas are: South on Burbank Blvd., from Hayvenhurst Ave. to the 405 Freeway and Haskell Creek from the Cricket Fields to the Orange Line. Both areas have large encampments with approximately 150 – 175 people living in the two areas. Both areas contain sensitive native plants and wildlife. Haskell Creek flows to the LA River and into the Wildlife Preserve. Schools frequently bring children to the Wildlife Area and often touch the water. The tons of waste in Haskell Creek flows into the Wildlife Area. These areas require heavy equipment and Hazmat Teams to remove the waste. A coordinated effort to clean up the area will consist of: CD 5 & CD6 Councilmembers, LA City Sanitation, LA County Officials and other City and State organizations. MOTION; EXE-19-06-0062: The ENC's Executive Committee seeks support from the Encino Neighborhood Council to take the lead in the coordinated effort to clean the following areas; South of Burbank Blvd., from Hayvenhurst Ave to the 405 Freeway & Haskell Creek from the Cricket Fields to the Orange Line due to the humanitarian and environmental impacts to the sensitive/native wildlife, plants, LA River and residents. These areas require heavy equipment and Hazmat Teams to remove the waste. A coordinated effort to clean up the area will consist of: CD 5 & CD6 Councilmembers, LA City Sanitation, LA County Officials and other City and State K Purcell motion / A Garay 2^{nd} (18,0,0) organizations., there is no cost to the ENC. **Passed: 5-0-0**



9-B. Homelessness Crisis in Los Angeles: Request that the Los Angeles City Council and Mayor Garcetti respond to the humanitarian, environmental, and sanitation crisis in all areas of the city including the San Fernando Valley and our local community, with the degree of urgency warranted. This would include deployment all possible resources, including logistical support and engagement of community leaders, to mitigate the rising health and safety issues resulting from people living in our streets and encampments.

MOTION; EXE-19-06-0063: The ENC's Executive Committee requests that the Encino Neighborhood Council support requesting LA City Councilmembers and Mayor to immediately respond to the humanitarian, public health, and environmental consequences of the homelessness crisis, including but not limited to requesting any state, federal, or other mutual aid assistance. **Passed: 5-0-0**

Airport Committee (Consent Items):

9-C. MOTION; AIR-19-06-0001: The Encino Neighborhood Council Airport Committee fully supports a voluntary late night/early morning curfew at Van Nuys Airport from the hours of 10:00pm-7:00am Monday-Friday, and 10:00pm-9:00am on Saturday-Sunday and holidays. Since it is voluntary, there is no downside to businesses, but it has the potential to raise the consciousness of operators and/or customers to at least take into account their responsibility to be a good neighbor. This voluntary curfew excludes emergency services. Moved by: Victoria Miller, 2nd: Jim Esterle, **Passed: 6-0-0**.

PLU Committee (Consent Items):

9-D. **AESTHETICS**. Except as provided in Public Resources Code Section 21099 (See supporting document, PLU AESTHETICS).

MOTION:

A – Committee has concerns about 2006 zoning changes which have changed the closeness of side yards – housing proximity to within 5' of the property line, which has the effect of closing off vistas and open space. Committee expressed concern about allowing anymore height to buildings as they will block vista and line of sight.

B – Include streetscape plan to preserve urban forest. Coordinate with Urban Forestry Division of the City of Los Angeles to preserve as many trees as possible and replace trees that have been cut down in the building process.

D – Committee believes we need to study the effects of Digital (LED) Billboards as they will add substantial light, glare and make our roads less safe as they compete for driver's attention.

G Bailey motioned to postpone until case number and address have been added (K Purcell 2^{nd}) (17,0,0)

9-E. AGRICULTURE AND FORESTRY RESOURCES – Refer to supporting document, PLU Agriculture & Forestry Resources.

MOTION: Committee has concerns about the potential loss of our 1 urban farm (Tapia Brothers) due and our 1 Vineyard (Wexler Encino Estate Vineyard) to zoning changes and the desire for more density on the part of planners. The ENC-PLU urges planners to keep favorable zoning (preserve and protect) for all agricultural endeavors in the Encino-Tarzana Community Plan update. As limiting food sources and locally grown produce would have a obvious detrimental environmental effect.

9-D: MOTION: The ENC PLU approves the CUP for the Jinya Ramen Bar subject to these amended conditions for the subject property: The hours of operation shall conform to LAPD suggested guidelines, which are from 11:00 AM to 1:00 AM Sunday through Thursday and 11:00 AM to 2:00 AM on Saturday and Sunday, and patio service from 11:00AM to 12:00 AM, seven days a week. Additionally, ambient music on patios should have volume not exceeding 70db measured 25 feet away from either the front or rear patio. Lee Blumenfeld proposed the motion; Henry Eshelman seconded it. **Passed: 4-2-0**

Address: 17237 Ventura Blvd – pushed back. Need revised LAPD report, Case number and address. (Case number is ZA2018-1411-F)

9-E: MOTION: The ENC PLU approves applicant request for a fence variance for the residence located at 3925 Archdale Avenue Encino. The request allows pilasters, fence and gates at a height of 6 feet at distances less than 25 feet within the front yard setback.
