A. Redistricting Poll – The ENC's Outreach Committee may conduct a poll on Nextdoor regarding the redistricting that will occur. The ENC may wish to formally send out the official position as to whether Encino should remain in Council District 5 as it currently is or if there needs to be a change. Gathering public input will help the board members understand the desires of the community. Without going into details about which communities should be in the same Council District as Encino, the poll should be kept simple with 3 available responses. There would be a description/definition of the redistricting occurring with the following question:

Would you like Encino to remain in Council District 5 keeping the existing communities or should Encino be in a district with neighboring communities:

- 1) Keep Encino in the current district everything is great
- 2) Encino should be in a district with neighboring communities make a change
- 3) Does not apply to me I keep to myself

Possible motion: OUT-21-09-0016; The ENC's Outreach Committee recommends that the board support a poll on Nextdoor asking residents: "Would you like Encino to remain in Council District 5, keeping the existing communities or should Encino be in a Council District with neighboring communities:

- 1) Keep Encino in the current district everything is great
- 2) Encino should be in a district with neighboring communities make a change
- 3) Does not apply to me I keep to myself

- C. Outreach Committee Budget: The ENC has allocated \$9300 in the budget for Outreach. As we start to move forward with in person events, what events should the ENC consider attending (having a booth) or supporting? Prior to Covid the ENC usually participated in: Los Encino Egg Hunt, One Generation Senior Symposium, Movie at the Park, one dog adoption day at the off-leash dog park in Encino, the Encino Family Festival as well as making contributions to the Community Center and to the Valley Disaster Preparedness Fair. The ENC has not participated in National Night Out and other local events not exclusive to Encino. Discussion and possible action.

- **D. ENC Elections** The past election cycle presented several issues and concerns. The ENC's Outreach Committee utilized the USPSs' Every Door Direct Campaign to make Encino residents aware of the NC elections. The cost of the printing and mailing only allotted for a one drop to all addresses in Encino. Ideally, 2 or 3 drops would be preferred however the NC's budget did not cover additional drops. In addition the ENC's website was updated to include step by step instructions on how to, apply to be a candidate, request a ballot and how to vote.
