A member of the public wishing to speak on more than one agenda item at a single meeting shall limit his or her remarks to a total of one minute per item and five (5) minutes per meeting. Members of the public who want to speak on multiple agenda items for up to five (5) minutes at one time can choose to speak during the Multiple Agenda Items Comment period. Otherwise comments from the public on agenda items will be heard only when the respective item is being considered. Members of the public who choose to speak during the Multiple Agenda Items period will be given the opportunity to also speak during General Public Comment. Community concern has been raised about the Mitigated Negative Declaration (MND) report as well as other issues. It is the President's recommendation that this matter be referred to the ENC Planning & Land Use Committee for consideration of the MND, any other related matters, and public comment at their next meeting, with the request that they report back to the ENC prior to its next meeting.

#### **B.** Outreach Committee:-

- 1. Encino Clean Up Day(s) There's a call to action in areas in Encino to have clean up days. One group is attempting to meet the 1<sup>st</sup> Sunday of each month (Area 3) and another cleans on Mulholland. In the past the ENC has sponsored and participated in a Clean Up Encino Day. With more areas looking to have clean up days, should the ENC partner with CD4 and perhaps the Chamber to coordinate & sponsor clean up days in Encino? Part of the sponsorship may be to purchase snacks and waters before the teams depart to clean the areas or as a light meal (pizza or other) when the items are returned. MOTION: The ENC's Outreach Committee recommends that the board support having the ENC coordinate clean up day(s) in Encino at multiple locations. The Outreach Committee further recommends that the board support having the ENC sponsor either the
  - pre-cleanup snacks, water and/or coffee or an after clean up light meal, such as pizza or similar with an expense up to \$350. Passed 4 (Y), 0 (N), 0 (A)
- 2. Trash Grabbers The ENC has participated and will most likely sponsor cleanup events in the community and should have an inventory of trash grabbers. Please see supporting document, <a href="STANDARD GRABBER">STANDARD GRABBER</a> for an image. The standard grabber is 32" and can pick up to 5lbs. Each grabber costs \$20. Please see supporting document, <a href="TOTAL COST FOR 30 GRABBERS">TOTAL COST FOR 30 GRABBERS</a>.
