4. New Business

- **A.** Election Bus Bench Adverts The ENC is able to purchase bus bench adverts and have them placed on bus benches in Encino, where available. The cost is about \$100 per advert we could use them to promote the upcoming NC election as well as the ENC. **Discussion and possible action.**
- B. ENC Election Flyers with QR Codes Should we create a 1 page flyer to place at local coffee shops and other Encino venues to promote the upcoming election. A simple flyer with QR codes for candidate filing and one to request a ballot? Cost would be minimal and would seek up to \$500 for printing costs. Possible Motion: The ENC's Outreach Committee recommends that the board approve up to \$500 for printing one page flyers to distribute at local venues (Starbucks, Coffee Bean, library etc.) with QR Codes as NC election advertising for candidate filing and ballot requests.
- C. Banner at Encino Little League \$1,000 for one 4' x 8' Banner to hang on an ELL field and a logo in the sponsor section of the ELL website. Artwork would be simple, our logo, Encino Neighborhood Council, www.encinonc.org and the city seal. Possible Motion: The ENC's outreach Committee requests that the board approve up to \$1200 for an 8' x 4' banner to hang at a Encino Little League (ELL) field and a logo in the sponsor section of their website.
- D. The ENC turns 20! The ENC turns 20 on October 8th. The entire board has not met since Covid started, with our upcoming birthday, should we host a board member & public potluck at Encino Park to celebrate? We need 30 days to schedule an event, the soonest possible date would be October 29th. Possible Motion: The ENC's Outreach Committee recommends that the board approve a 20 yr ENC Celebration at Encino Park on October 29th (time forthcoming) and further approve up to \$500 for refreshments Discussion and possible action.

E. Disaster Fair at Genesta Park – The Chamber, along with CD4 will host a disaster preparedness fair at Genesta Park on October 22nd and the ENC has been invited to have a table at the event. We should have something to hand out. In the past we have purchased glow sticks that were very popular. 250 glow sticks from 4Imprint, with Encino Neighborhood Council printed on each come to \$482.12 Possible MOTION: The ENC's Outreach Committee recommends that the board support the purchase of 250 glow sticks to hand out at the Encino Disaster Preparedness Fair on October 22nd at Genesta Park.
