Public Comment: Public Comments on Non-Agenda Items is limited to TWO MINUTES (2) per speaker. Time may be adjusted at the Chair's discretion. Public calling in, please press \*9 on your phone to raise your hand to speak. For those that are using the Zoom Webinar please use the raise your hand feature to speak. Public comment on agenda items will be heard when the item is up for discussion. Public comment on agenda items is limited to 1 minutes per

agenda item. Comments from the public on agenda items will be heard only when the respective item is being considered. Time may be adjusted at the Chair's discretion. SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public

using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control

that prevents members of the public from offering public comments using the call-in option or internet-based service

option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the

meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents

the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide
- an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or

other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference

may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public

comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until

that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each

agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public

comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the

purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda

item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general

public comment period has elapsed.

A. Planning for Back to School Movie Night Saturday August 10, 2024: We will finalize plans for our upcoming movie night at this meeting. We recommend allocating \$450 for three 4x6' signs from the local printing company, \$500 for water and popcorn, and venue rental and permit fees will be covered by the Recreation and Parks / Encino Community Center.

We need to figure out who is going to design the promotional materials on Canva. Who will stick around until the end to clean up. Who will be getting supplies and helping to set up. Who will be working the popcorn machine and cleaning it afterwards.
