- 4. New Business Motion, Discussion and Voting may be taken on all items:
 - **A.** Discussion on potential collaboration with Lisa Hart, Executive Director of the Los Angeles Neighborhood Council Sustainability Alliance (NCSA), to support outreach for a DWP-funded home electrification project in Council District 4. The committee will explore ways to assist with promoting the program through newsletters and social media and plan for a possible future presentation by Lisa Hart. **Discussion and Possible Action.**
 - **B**. Discussion on organizing a Children's Concert Initiative as part of Encino Children's Day, tentatively scheduled for January or February at Encino Park. The event will feature a series of concerts tailored for children ages two to five, creating a festival-like atmosphere. The committee will brainstorm ways to promote the event, engage families, and collaborate with local performers and organizations to make the event a success. **Discussion and possible action.**
 - C. Discussion on establishing a new protocol now that Kristen Moss and Aaron Devandry have joined the team. The committee will outline roles, responsibilities, and communication strategies, and determine key objectives to achieve moving forward. This will include brainstorming priorities and projects that the team would like to accomplish together to enhance community outreach efforts. Discussion and Possible Action.
 - **D.** Discussion and planning on how to maximize outreach for the LAUSD Elementary Magnet Academy for Enriched Sciences event that was awarded the Neighborhood Purpose Grant. The committee will strategize ways to effectively promote the event, including leveraging social media, newsletters, and community partnerships. We will also assign tasks for flyer distribution, digital promotion, and engaging local schools, parents, and relevant organizations to ensure strong attendance and community involvement.
 - **E.** Discussion on planning the content for the next Encino Neighborhood Council Newsletter for October. The committee will review potential topics, including upcoming events like the science school event on October 8th, local initiatives, and community updates. We will also determine

deadlines, assign content creation, and strategize on the best ways to engage the community through the newsletter.

- **F.** Discussion on outreach strategies for the Encino Community Center Halloween event through social media and marketing. The committee will plan the content and schedule for social media posts, including event details, engaging visuals, and community participation incentives. Additionally, we will explore collaborating with local influencers, community groups, and partners to amplify the event's promotion, as well as potential paid advertising options and flyer distribution to maximize attendance. Tasks will be assigned for content creation, posting, and community engagement.
- **G.** Discussion on outreach strategies for the Encino Burglary Prevention Event and Public Safety Town Hall Meeting on November 20th. The committee will plan to promote the event through social media, newsletters, and community partners, highlighting the importance of public safety and expert tips on burglary prevention. We will explore using targeted social media ads, collaborating with neighborhood associations, and distributing flyers at local businesses and community centers. Tasks will be assigned for creating and scheduling posts, contacting local media for event coverage, and engaging residents to maximize attendance and community involvement.

- **SB 411 Updates:** In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.
- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
